- 4. That the Second Party will establish, run and operate Common Bio-Medical Waste Treatment Facility at G-2,3,4, Growth Centre, Bijauli, Jhansi Uttar Pradesh.

This plant shall have the following facilities as per "Bio Medical Waste Management Rules 2016Amended in 2018&19":

- ❖ Incinerator (Capacity 200 ·Kg/Hr.) Double chambered, automatic Italian Burner, *PLC based panel*, Venture Scrubber and 30m height Chimney.

- Autoclave / Chemical treatment plant with a capacity of 800 Kg/Hr. with fully automatic controls.
- Shredder.
- Sharp Pits/Encapsulation.
- Deep Burial Pits in case of any emergency.
- Land for secured landfills.
- Effluent Treatment Plant.
- Storage Rooms one for untreated Bio-Medical Waste and another for treated Bio-Medical Waste.
- Destructor Machine with Capsule for Cytotoxic Drugs.
- ❖ Generator Room and Generating Set.
- Water Pump House.
- Laboratory for routine test.
- ❖ Disinfectant Tank to treat liquid Bio-Medical Waste.
- * Washing Platform for washing of vehicle.
- ❖ Dedicated Closed Vehicles permitted by R.T.O. fitted with GPS.
- Maintenance Room cum office.
- Total Secured Land for land filling and plant building covered by boundary wall and fencing with guardroom.
- ❖ Provision of Fire Extinguishers, Fire Buckets and Fire Insurance.
- Green Belt and Fencing in and around plant.

That the First Party will ensure that the complete Bio-Medical Waste generated at its premises is properly segregated and handed over to the Second Party for transportation, Treatment and Disposal of Bio-medical waste. As per WHO survey, generation of the Bio-Medical Waste per bed is around 250-300 gms per but it will charge same up to 500 gms/bed/day. & second party will charge extra @ 40/- kg for yellow (Incinerable) and @ 8/-kg for red bass (Autoclable).

- 6. That the Second Party will pick up the complete Bio-Medical Waste generated at the Premises of the First Party.
- 7. That the First Party will ensure that neither will it dispose of any recyclable Bio-Medical Waste in the open market nor will it dump any of its Bio-Medical. Waste in the Municipal Area.
- 8. That the Second Party will arrange material for Operation and Maintenance of the Bio- Medical Waste Treatment Plant and also for the disposal of the treated Bio-Medical Waste.
- 9. That the First Party having........Hospital/Pathologies/Blood Bank/ Surgical Clinic/Medical Clinic/Dental Chair/Veterinary Hospital/ Veterinary Clinic/Pharmaceutical Company and any other unit generating Bio Medical Waste to the Second Party for Transportation, treatment and disposal of Bio-medical waste.
- 10. That the Second Party can verify the actual bed strength in the premises of the First Party at any point of time.
- 11. That the Second Party will also transport, treat and dispose of unclaimed dead bodies and still born babies after all the legal formalities for the above are completed by the First Party. (These will be collected inside YELLOW BAGS) with extra charges.
- 12. That the Second Party will start collection of complete Bio-Medical Waste from the premises of the First Party immediately after signing this agreement.
- 13. That the Second Party will be collected Bio-medical waste on every alternate day except Sunday & national holiday however waste generated on Sunday will be collected on the next working day.
- 14. That the Second Party will raise a bill for the monthly charges for transportation, treatment and disposal along with supply of handling material as per "Bio Medical waste Management rules 2016Amended in 2018&19' to the First Party by the 7th of succeeding month through a Crossed Cheque/ Bank Draft drawn in favour of M/s MEDICAL POLLUTION CONTROL COMMITTEE, payable at Jhansi CASH WILL NOT BE ACCEPTED BY ANY WAY AND CONDITIONS.
- 15. That the Second Party may discontinue its services offered to the First Party, if the First Party defaults in payment of outstanding dues and matter can be referred to Uttar Pradesh Pollution Control Board / Central Pollution Control Board/Nagar Nigam for necessary action.
- 16. That the Second Party will charge 18% annual interest on the overdue outstanding dues of the First Party. The Second Party will start charging interest after the due date of payments.
- 17. That the Second Party will carry out transportation, treatment and disposal of the Bio-Medical Waste of the First Party as per the norms of the Ministry of Environment and Forests, Central Pollution Control Board and Uttar Pradesh Pollution Control Board and "Bio Medical Waste Management Rules 2016 Amended in 2018 & 19". - 18. That charges for authorization certificate from the Uttar Pradesh Pollution Control Board shall be borne by the First Party.

- 20. That all disputes, complaints, suggestions etc. shall be referred to the advisory committee and its decision shall be final and binding on both the parties.

- 22. That if the cost of direct inputs for running the Plant increases, the charges for transportation, Treatment and Disposal of Bio-Medical Waste will be increased proportionally after the decision of the advisory committee.
- 23. That the Second Party will charge as per Annexure -I(Rates will be revised once in a year) irrespective of occupancy for Transportation, treatment and disposal charges from the First Party along with supply of handling material as per Annexure II as per "Bio Medical Waste Management Rules 2016Amended in 2018&19".
- 24. That the First Party will have to pay as extra Service Tax or any other taxes and levies as applied by the Government to the Second Party Presently there are no such levies.
- 25. According to the Government notification of the Bio-Medical Waste Management Rules 2016Amended in 2018&19, in excise of powers conferred by section 6, 8 & 25 of Environment (Protection) Act of 1986, the First Party and the Second Party will be working in accordance of all the norms stated in the notification, rules, directions and agreement.
- 26. According to the Government Notification of the Bio-Medical Waste Management Rules 2016Amended in 2018&19 responsibility of the First Party shall be for the part for which it has taken authorization from the Uttar Pradesh Pollution Control Board and the responsibility of the Second Party shall be for the part for which it has taken authorization.

Terms and Conditions of Authorisation

- 1. The authorisation shall comply with the provisions of the Environment (Protection) Act, 1986 and the rules made there under.
- 2. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the prescribed authority.
- 3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the biomedical wastes without obtaining prior permission of the prescribed authority.
- 4. Any unauthorised change in personnel, equipment or working conditions as mentioned in the application by the person authorised shall constitute a breach of his authorisation.
- 5. It is the duty of the authorised person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.

Specific Conditions:

- 1. This authorization is valid for Bio Medical Waste incineration-100 Kg/hour through 01 No. Incinerator, Auto claving- 50 Kg/batch and shredding-50 Kg/hour.
- 2. New incinerator shall not be operated before obtaining the prior Environmental Clearance from MoEF&CC, Govt of India and CTE from U.P. Pollution Control Board.
- 3. Incinerator shall be operated in accordance with Bio-Medical Waste Management Rules, 2016 w.r.t. maintenance of Temperature for primary and secondary chamber of incinerator.
- 4. The CBWTF shall comply with provisions of the Environment (Protection) Act 1986 and the rules made there under.
- 5. The Authorization or its renewal shall be produced for inspection at the request of an officer, Authorized by the prescribed authority.
- 6. The Authorized person shall not rent, lend, transfer or otherwise transport the bio-Medical waste without obtaining prior permission of the prescribed authority.
- 7. It is duty of the Authorized person to take prior permission of the Board to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
- 8. CBWTF shall ensure that bio-medical waste shall be treated and disposed off in accordance with schedule-I and in compliance the standards prescribed in schedule-V of Bio-Medical Waste Management Rules 2016.
- 9. Bio- Medical waste shall be segregated into containers/ bags at the point of generation in accordance with schedule-I, prior to its storage, transportation, treatment and disposal. The Containers shall be labelled according to schedule-IV.
- 10. Bio-Medical waste shall not be mixed with Municipal or other wastes.
- 11. No untreated bio-medical waste shall be kept stored beyond a period of 48 hours. If it becomes necessary to store beyond 48 hours you must take permission of the prescribed authority and to ensure that it does not adversely affect human health and the environment.
- 12. CBWTF shall submit quarterly ambient air monitoring as well as stack monitoring report of incinerators done through Board's Laboratory on paid basis to ensure the prescribed norms.
- 13. The CBWTF has to maintain the computer recording of online monitoring, automatic feeding system, temperature recording of primary and secondary chamber.
- 14. Colour Coded and lid covered containers must be used for segregation & collection of bio-medical waste.
- 15. CBWTF shall submit an annual report to the U.P. Pollution Control Board in from IV by 31st January every year. And include information about the categories and quantities of Bio Medical waste during the preceding year.
- 16. CBWTF shall maintain record related to the generation, collection, reception storage, Transportation, treatment and disposal and / or any form of handling of Bio Medical Waste in accordance with rule and guidelines, all records shall be subject to inspection and verification by the Board at any time.
- 17. It is within the power and functions of U.P. Pollution Control Board to modify/ revoke the terms and conditions of Authorization and issued under the Rule 10 of the Bio-Medical waste Management Rules, 2016.
- 18. CBWTF shall submit the details of attached Pvt. & Govt. Hospital/ Nursing homes /Clinic etc. along with the No. of Beds within 15 days time after the receipt of this authorization.
- 19. Plastic shall only be sold to authorized recycler after proper disinfection and sterilization.
- 20. The occupier shall ensure compliance of Consent granted by Board under the provisions of Water (Prevention & Control of Pollution) Act, 1974 under section 25/26 and Air (Prevention & Control of Pollution) Act, 1981 under section 21/22 and also comply with the provisions of Hazardous & other waste (Management and Trans-boundary Movement) Rule 2016 and submit compliance report on quarterly basis.
